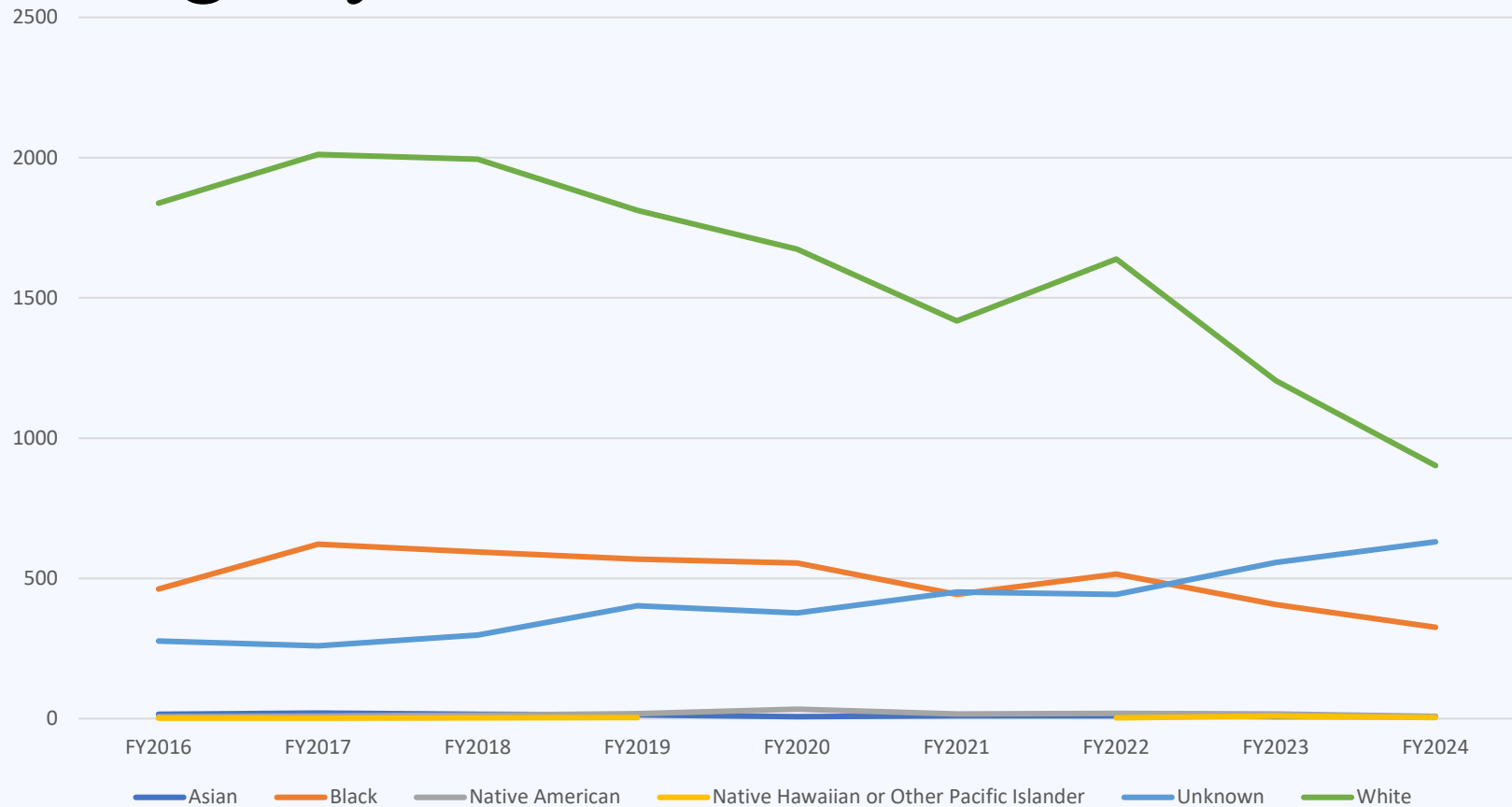

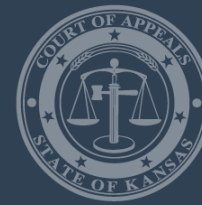

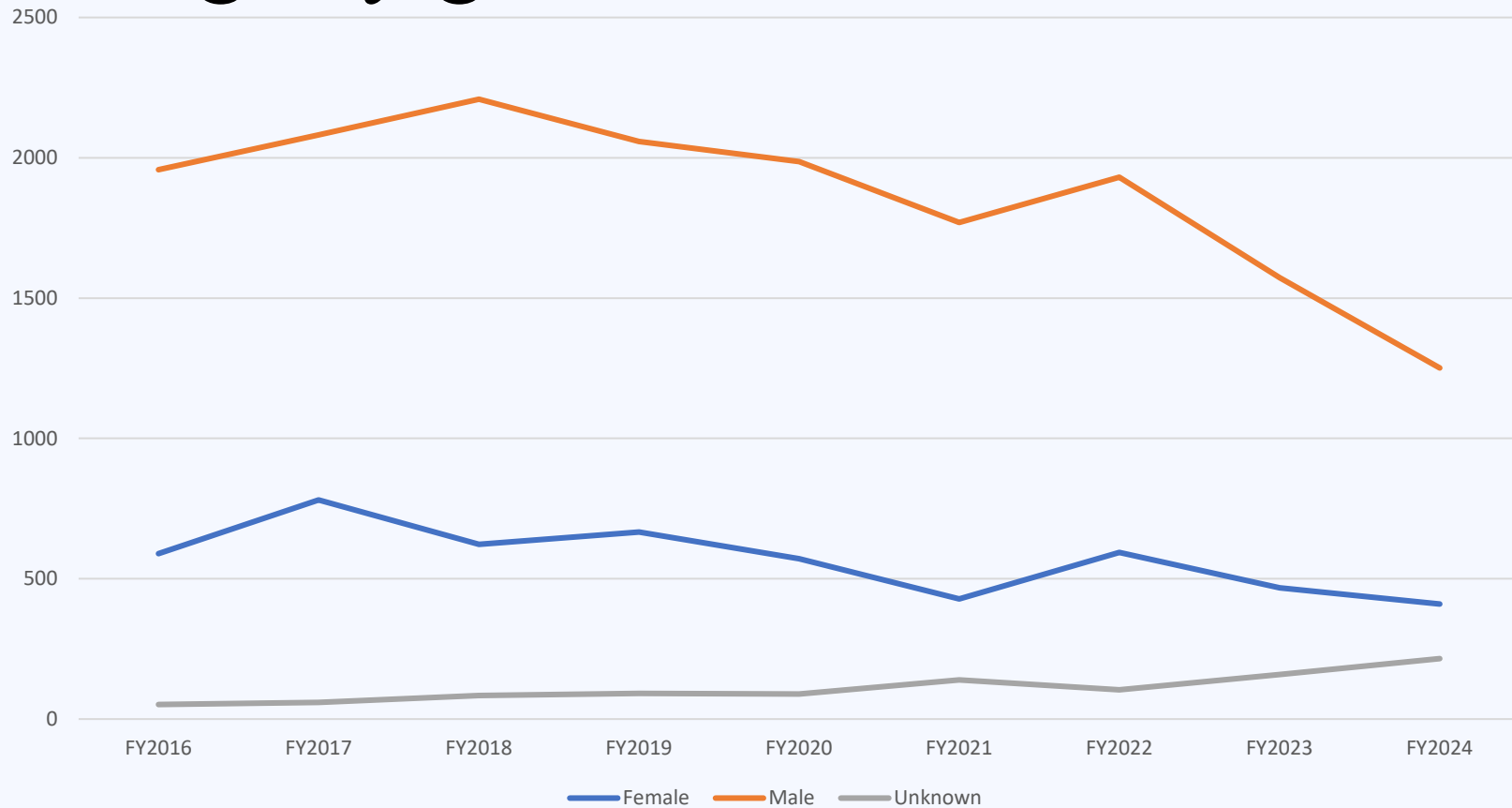


Total number of juvenile offender filings by race





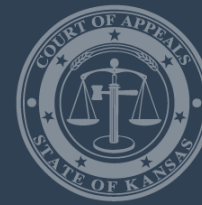
Total number of juvenile offender filings by gender





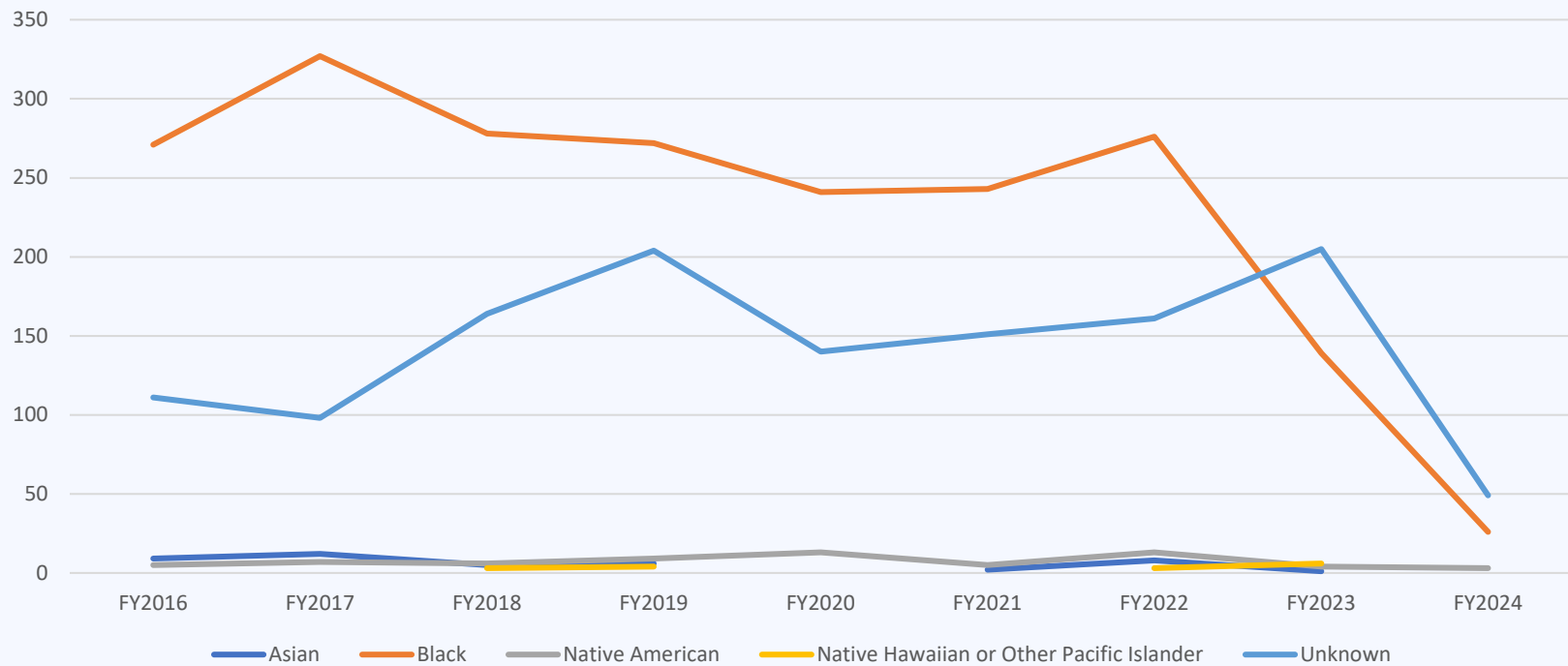

Total number of juvenile offender adjudications by race

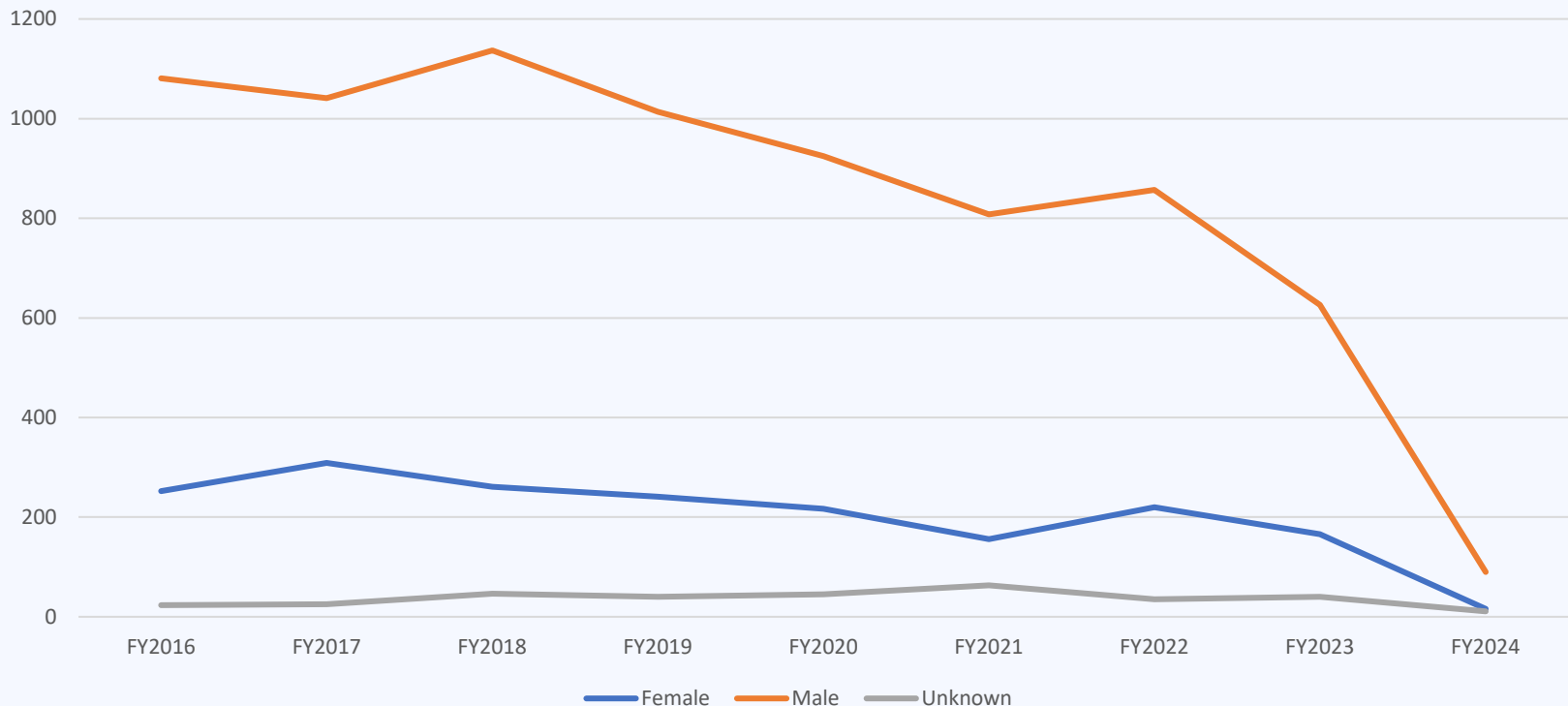
Adjudications by Race

Adjudications by Gender



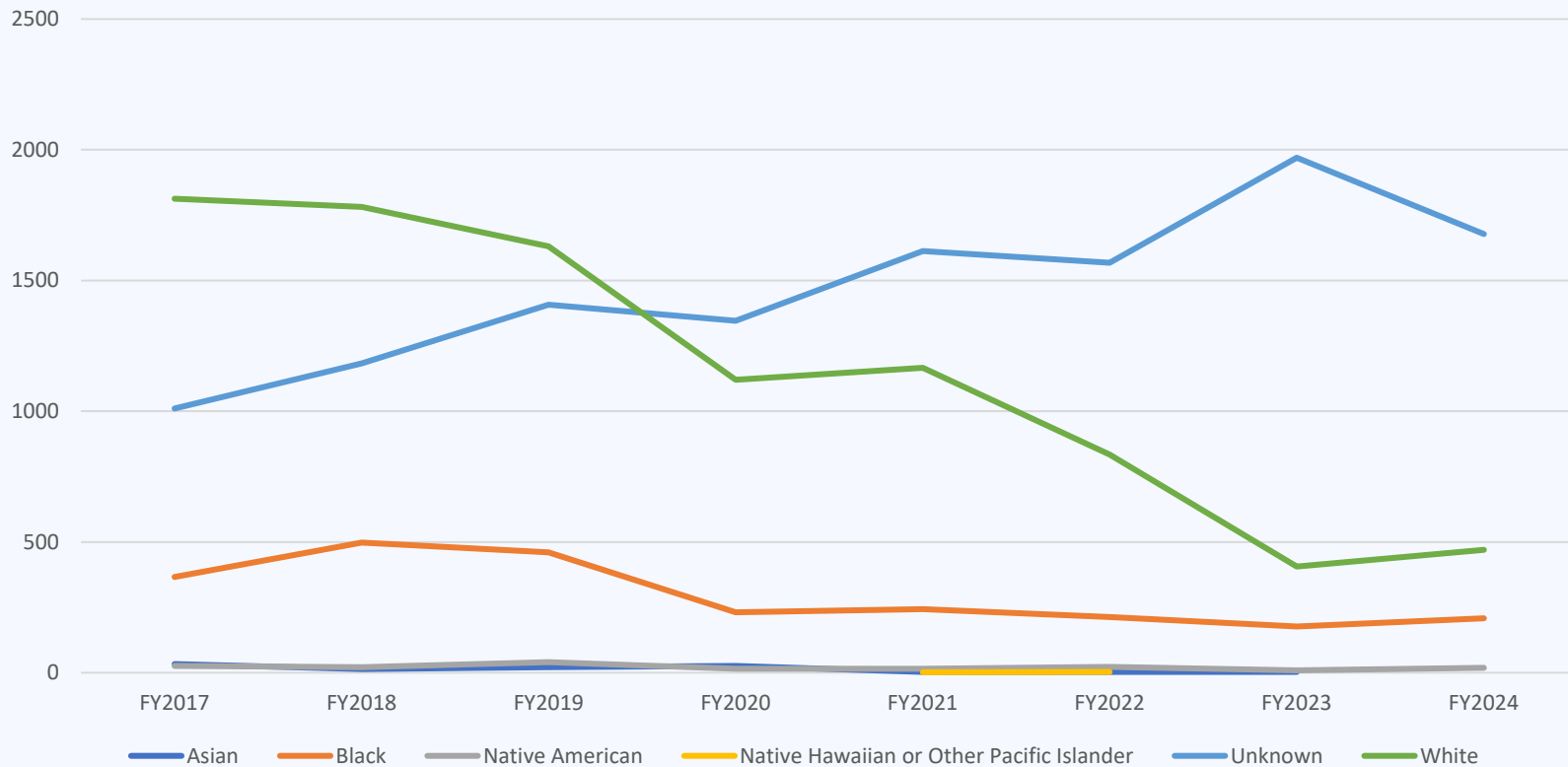

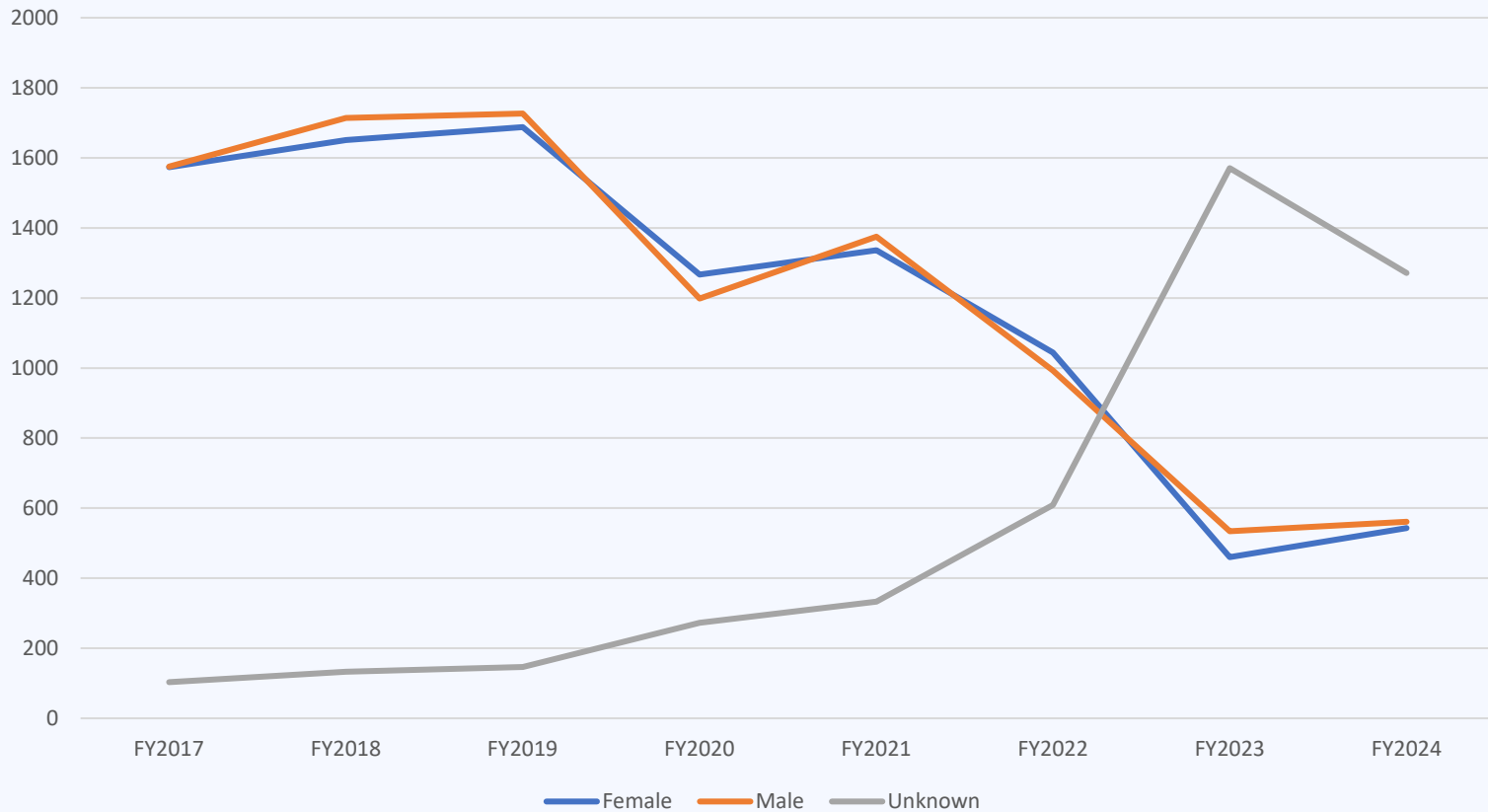


Total number of CINC filings by race

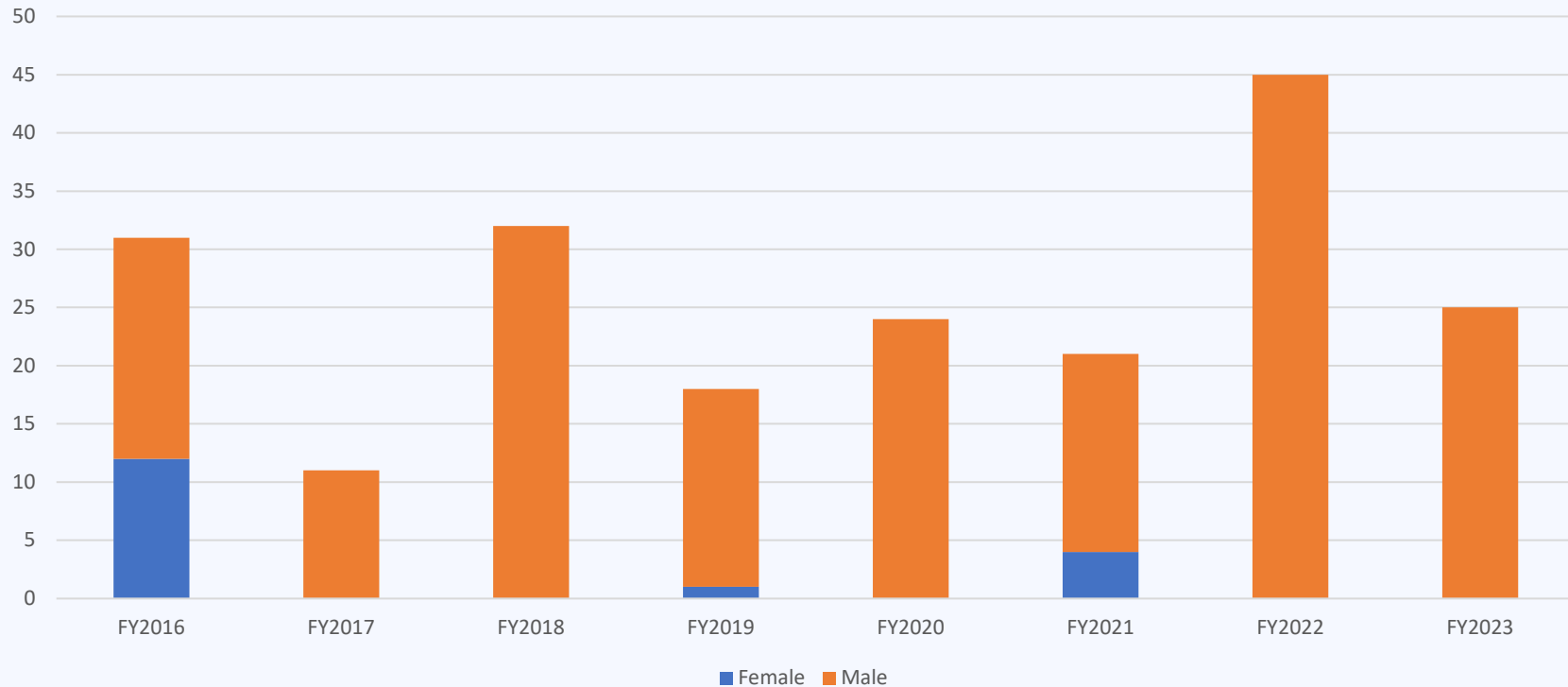


Number of cases transferred to the adult system by race



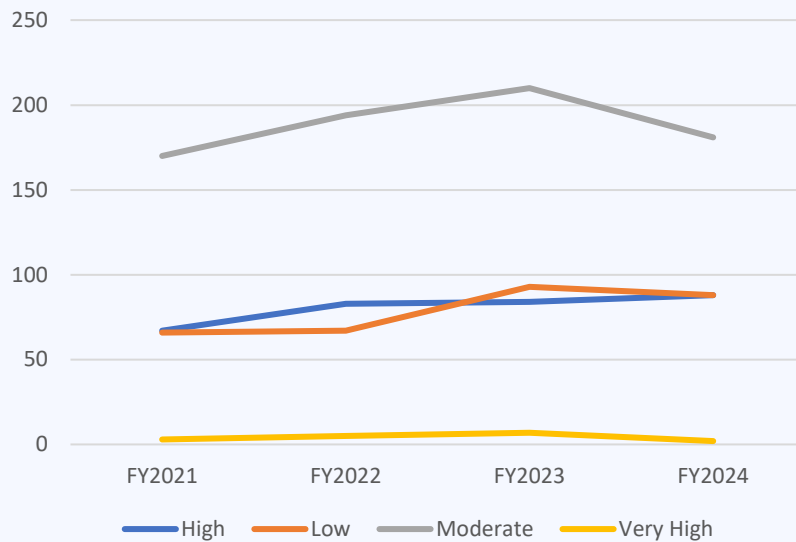


Number of cases transferred to the adult system by gender





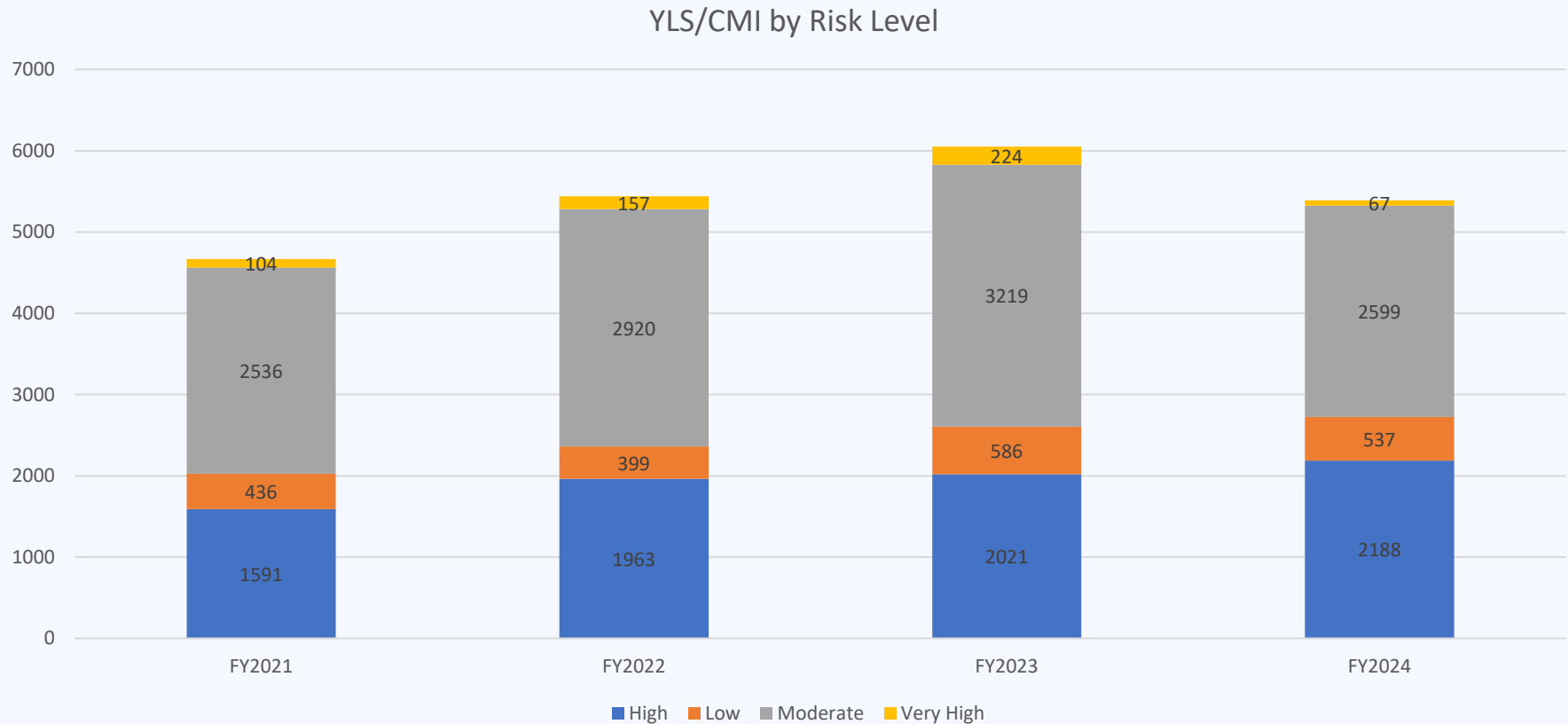

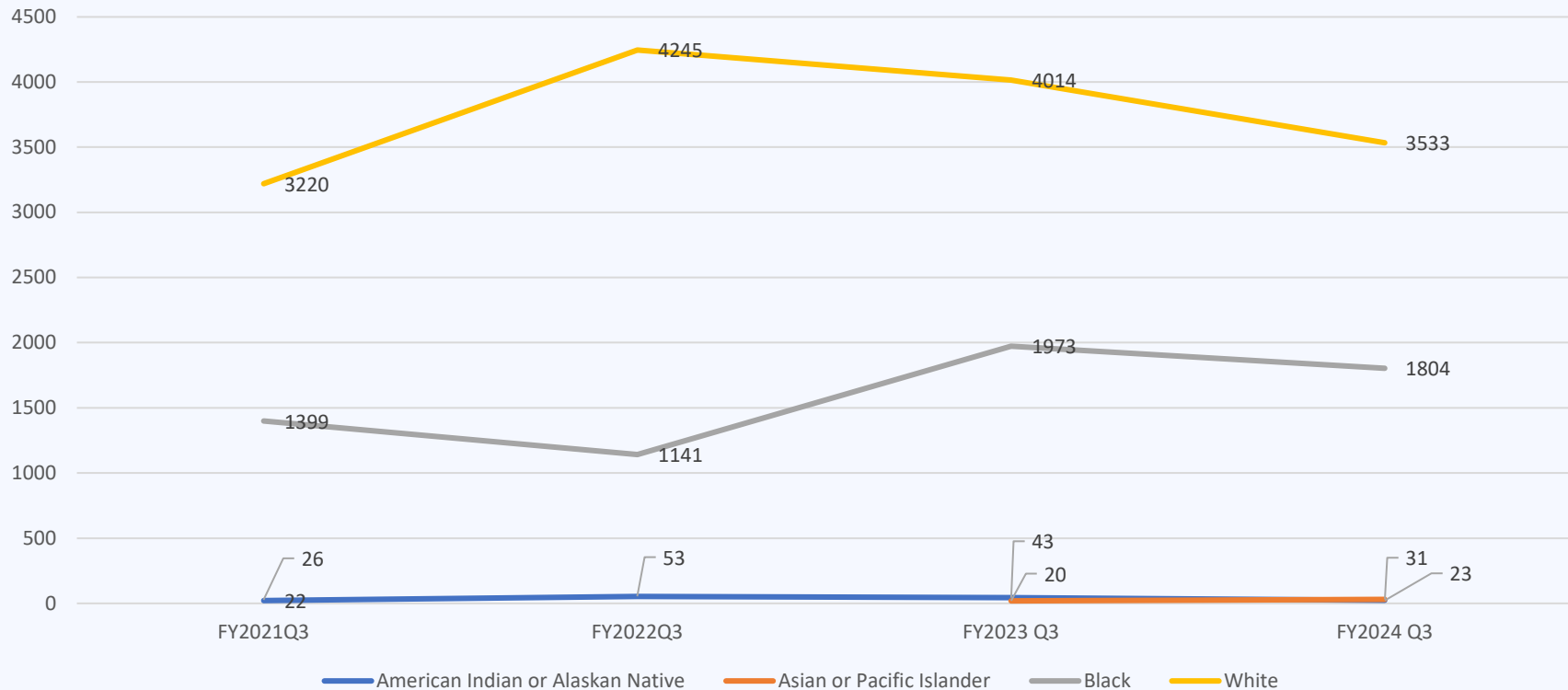
Total number of YLS/CMIs by risk level, (FY2021-FY2024)





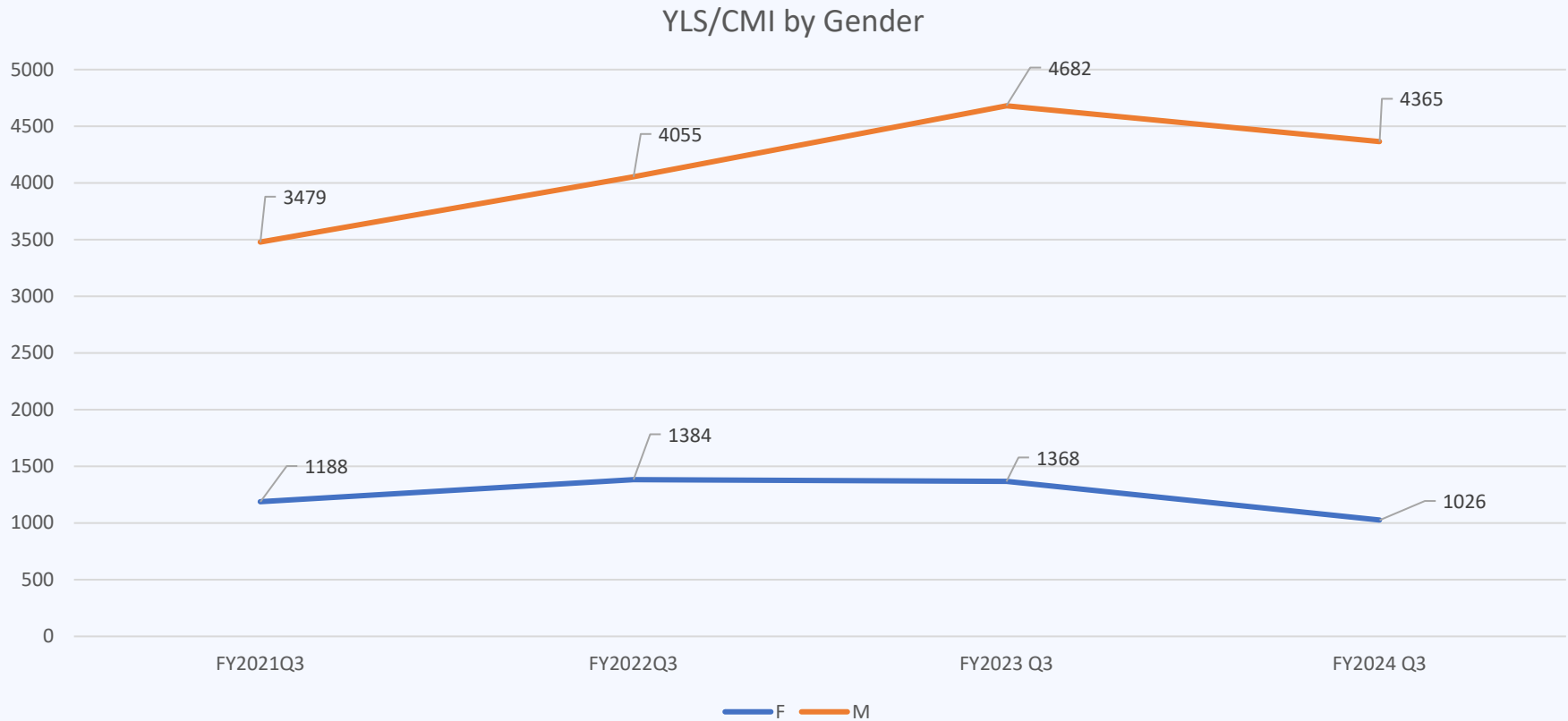
Total number of YLS/CMIs by race (FY2021-FY2024)

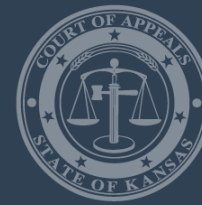
