Community-Based Treatment is currently ongoing in: Lenexa, Newton, Wichita, Manhattan, Pittsburg, Hays, Junction City, Beloit, Great Bend and Topeka. The following data has been collected regarding number of participants served, evaluation and treatment experience for FY19.

### Sexual Offender Treatment Program

- Total Discharged from Treatment FY19: 41
  - Low Risk: 28
    - Low: 7
    - Moderate: 2
    - Moderate-Low: 5
    - High: 1 (Length of treatment was 14 months)
    - Average Treatment Length for Low Risk Discharges: 6.42 months
  - Revoked: 3 (Lawrence, Wichita, Larned)
  - Terminated from Treatment: 1 (Lenexa)
  - Sentence Expired: 9 (Junction City, Lenexa, Wichita, Great Bend, Garden City)
  - Of the 41 discharged:
    - 32 received individual therapy/ 9 received group
    - 35 lived at home (1 at Pathways, 4 Pratt County Achievement, 1 JRF)
  
- ACE Data for those in Treatment
  - Risk Level
    - Low (Avg. ACE = 1)
    - Moderate Low (Avg. ACE = 2)
    - Moderate (Avg. ACE = 1)
    - Moderate High (Avg. ACE = 1)
  
- 140 Clients have been evaluated and not referred for treatment since July 2016
  - 45 were not recommended for treatment
  - 95 were recommended for treatment
