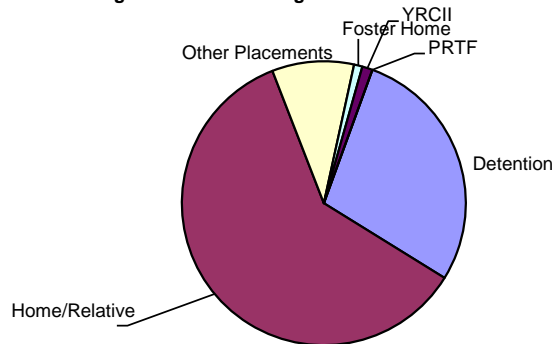

FY20 Average Placement Setting Distribution for DOC Custody Youth

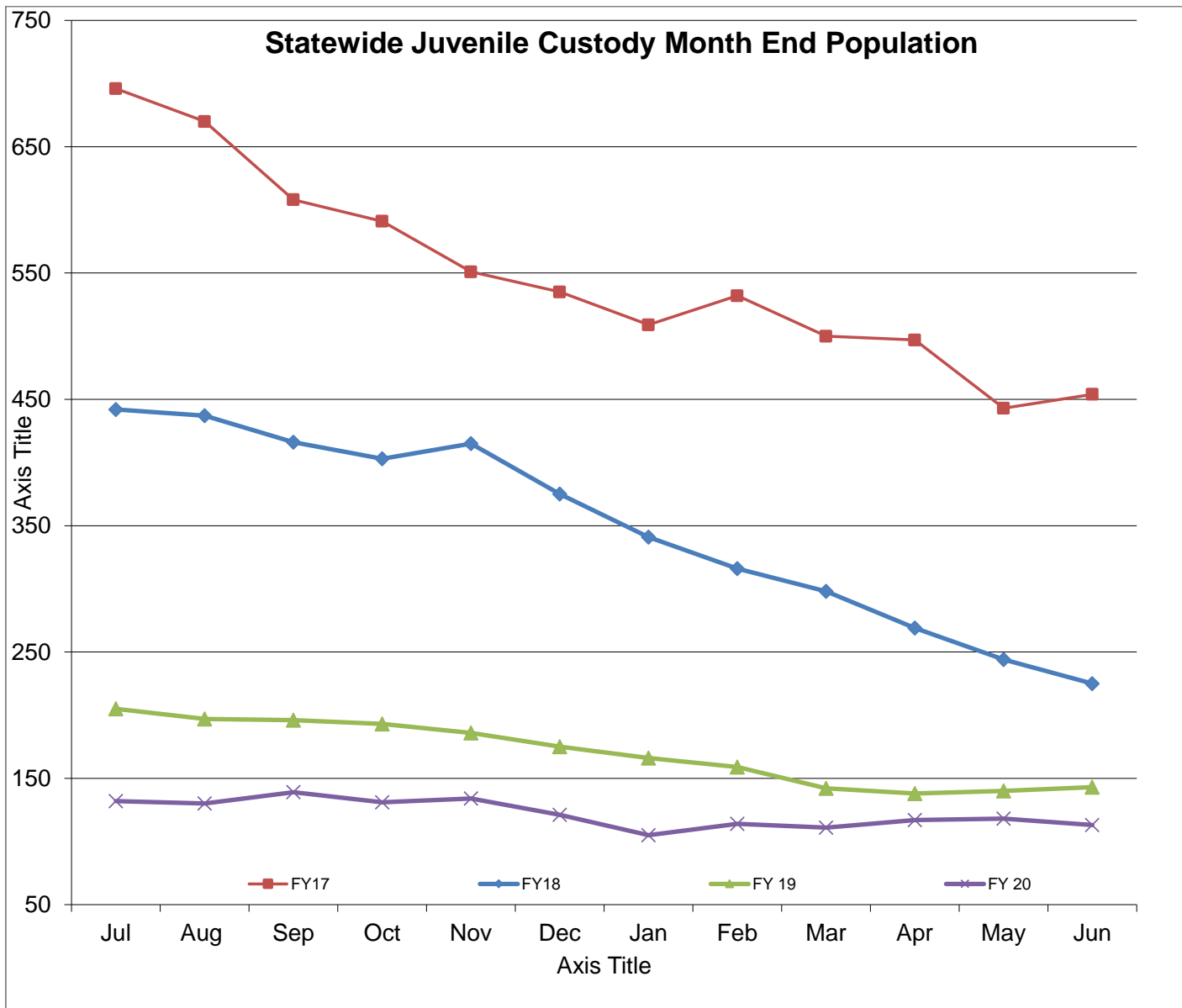

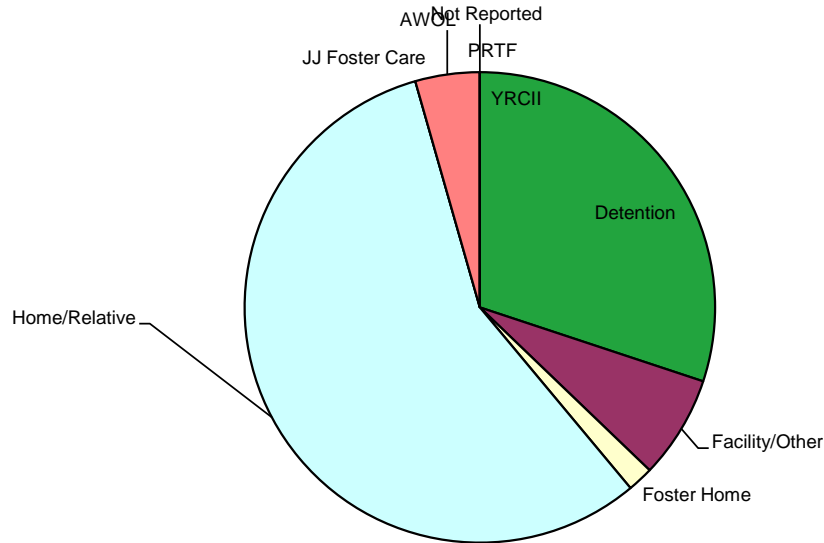

Month End Placement Distribution



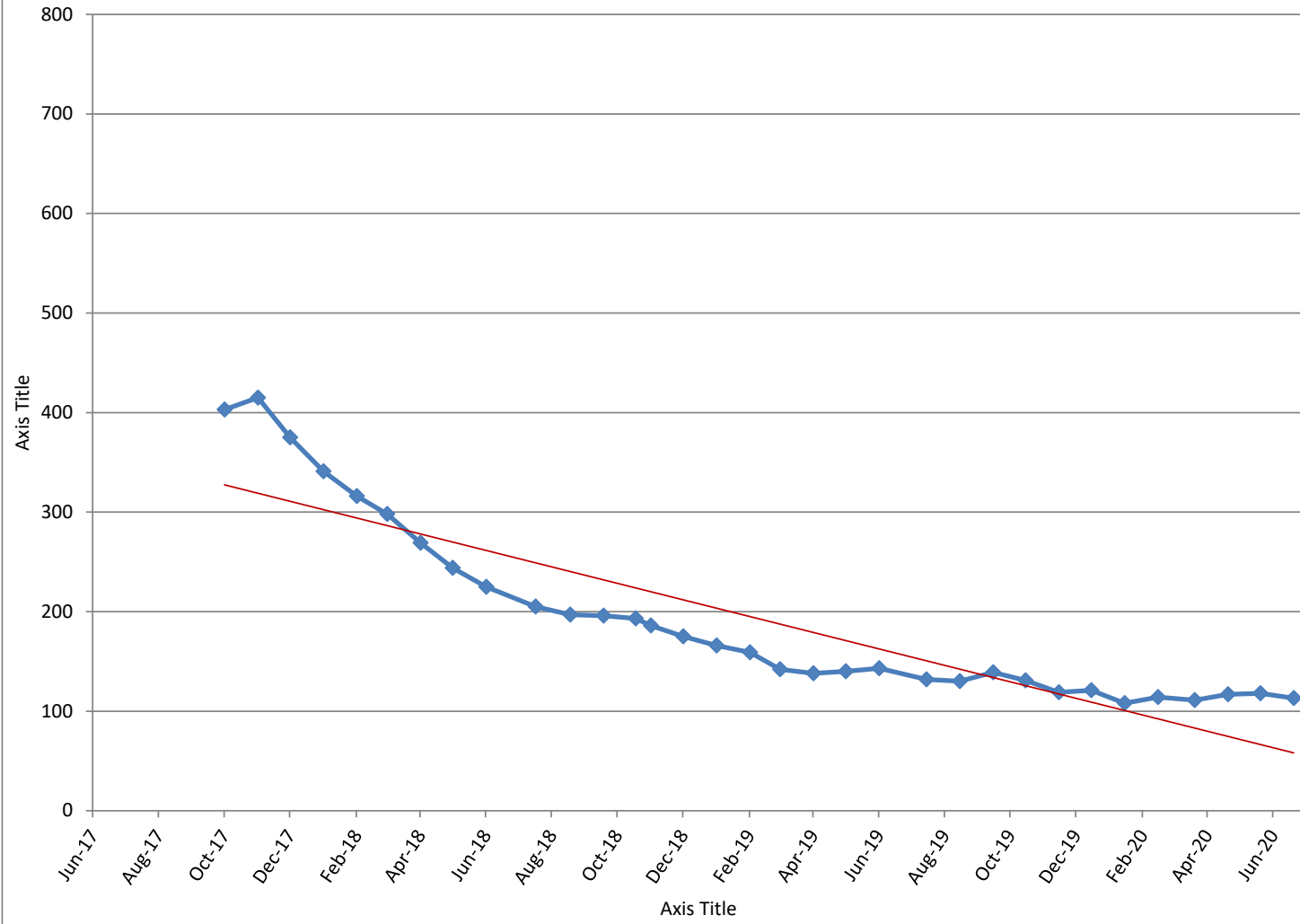

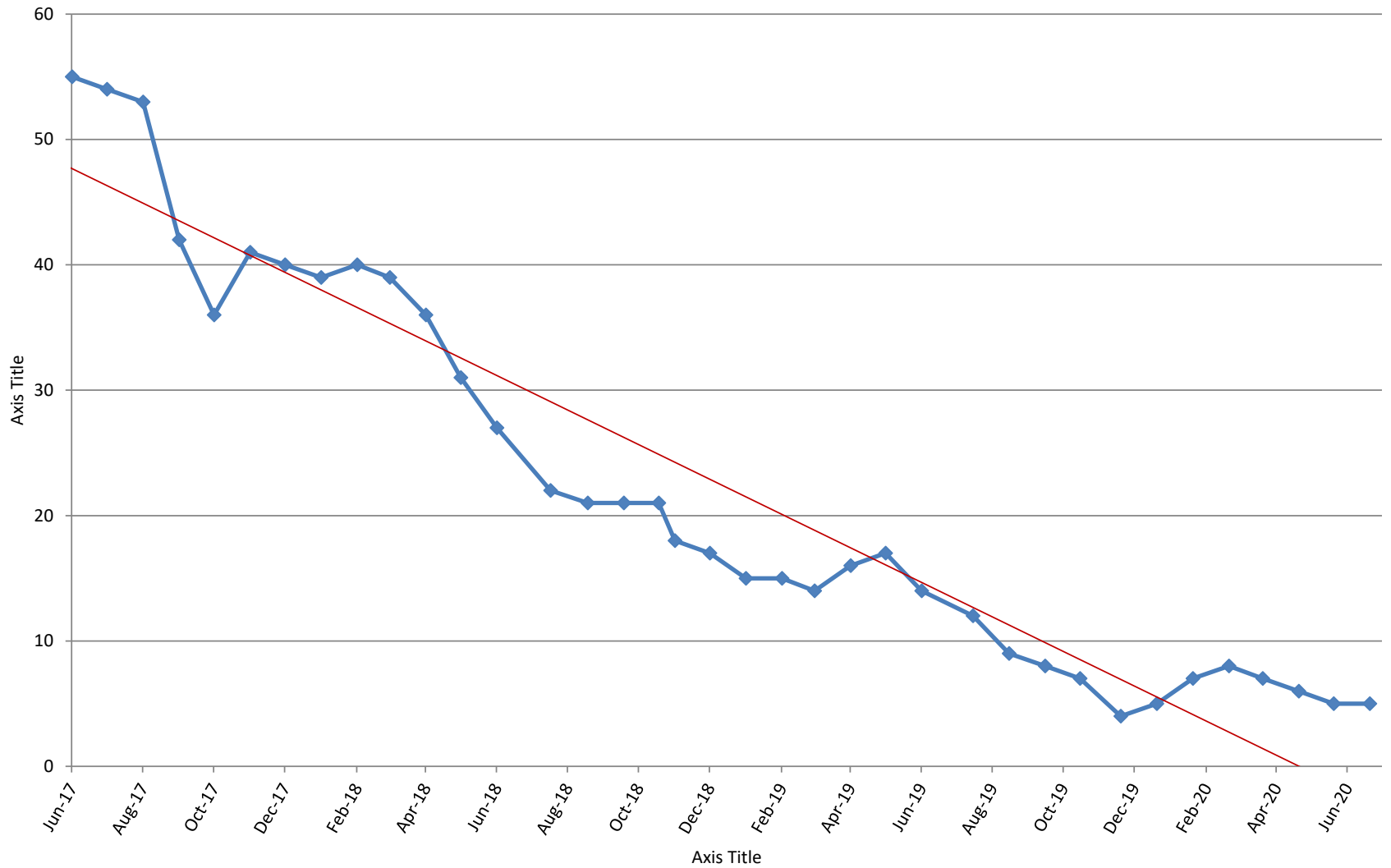
